STRATEGIC PRIORITY AREA 1: CHARACTERIZATION, INVENTORY AND MONITORING OF TRENDS AND ASSOCIATED RISKS

Actions undertaken during the past year

All populations of farm animals included in the conservation programme are monitored at the annual basis. This is the task of Species Coordinators who provide their reports to the respective Working Groups. A substantial increase in population size in majority of breeds under the conservation programme has been observed in the last year;

Revised performance evaluation programmes have been developed and implemented in case of pig, sheep and poultry breeds. The results of performance evaluation carried out in 2007 have been published and wildly distributed in 2008;

Field work - on-farm evaluation and selection of individual animals to be introduced into the restoration programme of the Polish Merino in the old type has been completed in 2008;

A number of research projects has been undertaken at varius agricultural univesities/institutes aiming to enhance genetic characterisation of native breeds.

Two MSc projects were undertaken to analyse genetic status (inbreeding level and contributin of valuable ancestors) of the Sztumski and Sokolski coldblooded horsebreeds which are included in the conservation programme.

Actions planned for the next year

Ongoing monitoring and performance recording of breeds under the conservation programme;

Various studies to characterise breeds under conservation programme will be either continued or initatied.

STRATEGIC PRIORITY AREA 2: SUSTAINABLE USE AND DEVELOPMENT

Actions undertaken during the past year

Continous discussion on development of specific products from native breeds;

Further development of the scheme to support breeders to control inbreding level in a small population of Olkuska sheep;

New inittaitives, in collaboration with the NGOs to develop and popularize innovative options for utilisation of coldblodded horses.

Actions planned for the next year

Continuation of efforts to develop specific, unique products from native breeds;

Strenghtening cooperation with breeders societies to promote implementation of the Global Plan of Action for Animal Genetic Resources, especially in the context of maitaining within breed diversity.

STRATEGIC PRIORITY AREA 3: CONSERVATION

Actions undertaken during the past year

Routine evaluation of progress achieved in implementatin of the conservation programmes; introduction of relevant ammendments, where necessary;

Cooperation with the Ministry of Agriculture and Rural Development in implementation of the Package 7 within the Rural Development Programme 2007-2013, under Agri-environment;

Adjustment of existing procedures for documents' flow to facilitate breeders' participation in the conservation programme financed through the agri-environmental measures, Package 7;

Finalisation of conservation programmes for coldblooded Sokolski and Sztumsk horses, Polish back and white cattle, Podhale cakiel and old type of Polish Merino sheep;

Extensive consultation with Polish Horse Breeders Association and development of proposals to enhance requirements for participation in the conservation programmes especially in case of Malopolski and Wielkopolski horse breeds;

Introduction of new breeds into the conservation programmes: 8 colour varieties of nutria (Grenland, Standard, Black dominant, Amber-gold, White non Albino, Sable, Pastel and Pearl);

Inspection of selected farms participating in the conservation programme.

Actions planned for the next year

Coordination and assessment of implementation of the conservation programmes:

- for cattle, horses and sheep and pigs (measures included in the package P7 of agrienvironmental programme, Rural Development Programme framework 2007-2013);
- for remaining species: poultry, fur animals, honey-bees and fish (state measures for animal breeding development within annual budget of the Ministry of Agriculture and Rural Development);

Re-visiting conservation programmes for some breeds;

Strenghtening efforts to establish national ex-situ genebank for animal genetic resources.

STRATEGIC PRIORITY AREA 4: POLICIES, INSTITUTIONS AND CAPACITY BUILDING

Actions undertaken during the past year

Initiation of discussion in the Ministry on preparation of the National Strategy and Action Plan – due to the economic crisis the financing of the work had to be postponed.

Consideration of establishment of the Foundation for Animal Genetic Resources Conservation.
