RULES OF THE LIST OF GENETIC RESERVE OF DOMESTIC ANIMALS, WAYS OF PRESERVATION OF GENETIC RESERVE OF DOMESTIC ANIMALS, AND A LIST OF INDIGENOUS BREEDS OF DOMESTIC ANIMALS AND ENDANGERED OF AUTOCHTHONOUS BREEDS

Announced at ("Official Gazette RS", No. 38/10)

I. INTRODUCTORY PROVISIONS

Article 1.

This regulation prescribes the List of genetic reserves of domestic animals and method of preserving genetic reserves of domestic animals and determine the List of indigenous breeds of domestic animals and endangered native breeds.

II. THE LIST OF GENETIC RESERVES OF DOMESTIC ANIMALS, METHODS OF PRESERVATION OF GENETIC RESERVES OF DOMESTIC ANIMALS, LIST OF INDIGENOUS BREEDS OF DOMESTIC ANIMALS AND ENDANGERED INDIGENOUS BREEDS

Article 2.

Genetic reserves of domestic animals include some breeds, strains and lines of domestic animals are kept in mind the minimum number of domestic animals, the doses of semen, ova and embryos, in accordance with the law governing livestock.

List of genetic reserves of domestic animals shall be determined depending on the species of animal and the desired sex ratio, and represent the smallest number of domestic animals (adult animals) some species, or breed of domestic animals, needed for breeding and preserving their genetic diversity.

List of genetic reserves of domestic animals under paragraph 2, this article is given in Annex 1 - List of genetic reserves of domestic animals, which is attached to these Regulations and forms an integral part.

Article 3.

Preservation of genetic reserves of domestic animals is done on one of the following, ways:

1) In situ or On farm - including conservation and raising of live animals in the production systems where they occurred or are now, and that includes both the farms and extensive production systems;

2) Ex situ - including conservation outside of the production systems where animals are formed, which can be:

(1) In vivo - breeding of live animals in the zoo, nature parks, museums, research institutes, etc.;

(2) In vitro - crioconservation of embryos, sperms, fertilized egg cells, DNA, somatic cells and other biological materials that may be used for the reconstitution of the animals.

Article 4.

List of indigenous breeds of domestic animals and endangered indigenous breeds is given in Annex 2 - List of indigenous breeds of domestic animals and endangered indigenous breeds, which is attached to these Regulations and forms an integral part.

III. FINAL PROVISION

Article 5.

This Regulation shall enter into force eight days after its publication in "Official Gazette Republic of Serbia".
