**RULES ON THE CONDITIONS OF BREEDING AND TRADE
OF INDIGENOUS BREEDS DOMESTIC ANIMALS, AS
LIKE CONTENT AND METHOD OF MANAGEMENT OF
REGISTER OF THE INDIGENOUS BREEDS OF DOMESTIC
ANIMALS**

Announced at ("Official Gazette RS", No. 56/10)

I. INTRODUCTORY PROVISIONS

Article 1.

This regulation setup conditions in terms of breeding and trade of indigenous breeds of domestic animals, as like the content and methods of management of Register of ndigenous breeds of domestic animals (Register).

**II. CONDITIONS IN TERMS OF BREEDING AND TRADE OF
AUTOCHTHONOUS BREEDS OF DOMESTIC ANIMALS**

Article2.

Breeding of domestic animals, in terms of these Regulations, is a sets of genetic and zootechnical practices for the manifestation of the productive potential of animals. Autochthonous breeds of domestic animals are raised in a pure breed.

Article 3.

Autochthonous breeds of domestic animals are raised on:

- 1) an extensive way;
- 2) semi-intensive way;
- 3) intensive way.

Article 4.

In order to preserve habitats in which indigenous breeds of domestic animals occurred, the indigenous breeds of domestic animals are raised on traditional way of production systems with low input-extensive way.

For better implementation of the breeding objectives, increasing the efficiency of selection and conservation of a particular breed, the indigenous breeds of domestic animals can be are raised on semi-intensive and intensive way.

Article 5.

The trade of indigenous breeds of domestic animals includes import, export, transit, saling, purchase or any transfer them to the third parties, in accordance with the law governing livestock.

Article 6.

Each trade of indigenous breeds of domestic animals must be reported on primary breeding organisation, in accordance with the law governing livestock.

Trade of indigenous breeds of domestic animals shall be in accordance with prescribed veterinary and sanitary conditions.

**III. CONTENTS AND METHODS OF KEEPING
THE REGISTER OF INDIGENOUS BREEDS
OF DOMESTIC ANIMALS**

Article 7.

Registration in the Register shall be based on requirements that the owner of domestic animals-natural or legal person or entrepreneur apply to the Ministry of Agriculture, Forestry and Water Management (here in after: Ministry), in accordance with the law governing livestock.

The request under paragraph 1, this article contains the following informations:

- 1) name, surname, address, life number for physical person;
- 2) the name and address, telephone number and email address for the legal person and entrepreneurs;
- 3) identification number, tax identification number (here in after PIB) and current account for legal entities and entrepreneurs;
- 4) the number of registered agriculture farms;
- 5) the name of the breed for which the application is made;
- 6) number of animals according to the breed and category for which the application is for registration.

Along with the request under paragraph 1, this article shall be:

- 1) confirmation of the number of animals according to the breed and category for which the application applied. This confirmation must be certified by a major breeding organizations;
- 2) proof of payment of administrative fees.

Contributions under paragraph 3, this article shall be submitted in original or certified copy.

The request under paragraph 1, this article shall be in Form-Application for registration of indigenous breeds of domestic animals, and which is printed here in and it is an integral part.

Article 8.

Register contains the following informations:

- 1) number and date of registration in the Register;
- 2) the name and address of the natural person or legal name and address

individuals and entrepreneurs, address, phone number and email address of legal entity and entrepreneurs;

- 3) the number of registered agriculture farms;
- 4) PIB (tax identification number) for legal entities and entrepreneurs, or life number for physical person
- 5) the change of registered data;
- 6) number and date of entry or decision on removal from the Register;
- 7) number of animals according to the breed and category.

Article 9.

The register is kept at the Ministry in electronic form.

Article 10.

The Register noted the change in the data.

Change of data under article 8, point 5) of these Regulations apply two times per year, as follows:

- 1) for the period from 1. May until 31. October, by 15 November;
- 2) for the period from 1. November until 30. April, by 15 May.

Article 11.

The person authorized to conduct the Registry shall maintain the Register and the data for registration in a manner that ensures protection from abuse, damage and destruction of the Register.

A register shall be made with the presence of an authorized person referred to under paragraph 1, this article.

IV. FINAL PROVISION

Article 12.

This Regulation shall enter into force eight days after its publication in „Official Gazette Republic of Serbia “.
