

Minutes of the ERFP Assembly of National Coordinators

9th and 10th of September, webconference

Chair: Sipke Joost Hiemstra, NC The Netherlands

1. Welcome and opening

Sipke Joost Hiemstra, the Chair of the ERFP Steering Committee, welcomed the Assembly. He thanked the Secretariat for its organization.

The Agenda is presented with modifications for day 2. There are no further amendments; the agenda is accepted.

2. Report from the ERFP Secretariat

Cf. <u>slide presentation</u> and written report (1_ERFP_Secretariat_WrittenReport_Assembly_2021 Final.pdf) prepared by the Secretariat prior to the GA meeting. The written report was amended by the SC and GA, therefore the new version is sent with the GA minutes.

ERFP Annual Progress report

The presented Annual Progress Report 2020-2021 was approved by the Assembly.

ERFP Financial report

All the budget figures are included <u>in the secretariat report</u>. Since the minutes are public, for security reasons these elements are not included in the General Assembly report or on the slides to be found on the ERFP website.

The presented final budget for 2020 was approved by the Assembly.

For the second consecutive year, the sanitary situation has great impact on the budget expenses since neither the WG meetings nor the GA were held physically in 2021.

On the other hand, the use of virtual meetings allowed the SC to meet 5 times this year, and allowed new ways of communication from ERFP such as the Merino and genebank webinars and the ERFP webinar to be held September 9th. Some Ad Hoc actions (development of genebanks, Transboundary breeds) also used this way of communication to meet at frequent interval.

3. Reports from the ERFP Working Groups

All chairs briefly summarized the work of the group and future plans. All the details are described in the written report that were provided before the General Assembly and in the



slide presentations. Reports of the various Ad Hoc actions were also provided before the General Assembly; a recap of all the AHA started in 2020 are provided in the Secretariat report.

In Situ Working Group: a new task is suggested by the GA which is to collect all the strategic plans drafted by the EU countries for the new CAP.

The ERFP SC chair congratulates Fernando Tejerina for its nomination as a chair for the *ex situ* WG.

During the presentation of the Ex Situ WG report, Fernando Tejerina asked the General Assembly on several issues:

- Advances in the development of documentation software:

Since a common project for all ERFP countries does not seem to be realistic, the chair suggests that each country develop a software with their own resources. However it is suggested to develop a Task Force to coordinate efforts and reduce costs.

- ⇒ The proposal is accepted by the General Assembly.
- Proposal to change EUGENA ToR into a one-step procedure: Germany warns countries that when signing such a MoU, they need to assess the situation before:
- i) NCs need to make sure that they are in the position to sign on behalf of their country and genebanks;
- ii) that all relevant national legislation is followed by the genebanks, including ABS, Animal Health, etc.
 - ⇒ The proposal is accepted by the General Assembly.

EFFAB offers to be involved more actively in the *ex situ* WG since one of their task is to develop guidelines for cryoconservation, in order to avoid duplication.

All presented reports and work plan were approved by the Assembly.

• TF permanent secretariat

The work of this TF was put on hold with the development of the two strategies of the GenResBridge project. The implementation of the strategies will have a repercussion on how a permanent secretariat could be set up. Meanwhile it was difficult to discuss the need for higher country contributions if such an organisation is implemented while the covid situation led ERFP in having bigger savings.



4. FAO report

The GenResBridge project is also an opportunity to increase the awareness around EFABIS; workshops are organized to help NCs entering their data and more virtual meetings are planned in order to show what are the benefits and uses that can be provided by EFABIS.

5. Progress report by the EAAP WG-AnGR

Cf. slide presentation.

In the absence of Jesus Fernandez due to last minute unforeseen circumstances, the secretariat is presenting his slides. Jesus Fernandez's term as EAAP WG-AnGR chair is achieved, and Peer Berg was elected to replace him. The General Assembly congratulates Peer for his election and thanks Jesus Fernandez for his commitment and good interaction with the ERFP network.

Ana Granados (EFFAB) is letting ERFP know that EFFAB is facing the same issues about invited speakers and the visibility of challenge sessions for instance. EFFAB is having undergoing discussion with EAAP about these issues; some connections could be done with ERFP so we could solve our issues together.

6. ERFP 2022 Future plans

Cf. secretariat report and slide presentations.

It is suggested to the General Assembly that since the Covid situation led to savings, the funding could be used to **strengthen** our communication strategy and to **implement** new Task Forces (TF° as well as Ad Hoc Actions. It is reminded to the NCs that TF need a General Assembly approval while Ad Hoc Actions can be validated by the Steering Committee.

The <u>Task Force about Transboundary breeds</u>, led by Enrico Sturaro and Eleonore Charvolin, is <u>approved</u>.

The proposal to merge the TF "Permanent Secretariat" with the follow-up of the EGRS and Animal Strategy is **approved**. Sipke Hiemstra agrees to lead this TF.

Fernando Tejerina reminds the General Assembly that, following his presentation about the Ex Situ Working Group, he would like to create a Task Force to collectively analyse the costs and benefits of a genebank software. This Task Force, led by Fernando Tejerina, is **approved**.

A discussion follows the presentation on the TF about breeding programs. A first step is needed beforehand that would first analyse the current situations, during an Ad Hoc Action for instance. The implementation of indicators or guidelines would be a second step to implement based on the results of the Ad Hoc Action. The implementation of the breeding



program TF is therefore **postponed.** An Ad Hoc Action will be drafted for the next Steering Committee, Ana Granados (EFFAB) is willing to be part of it. The leadership of the AHA is still to be decided.

The Assembly approved the presented future plans and budget proposal for 2022.

7. Elections

<u>ERFP Chair</u> - according to the ERFP Terms of Reference, the term of office for the current Chair of the Steering Committee Sipke Joost Hiemstra ends in 2021. **Montserrat Castellanos Moncho** (Spain) is candidate for the election. An email was send to all NCs and no other proposal was received. The candidate introduced herself to the GA.

The General Assembly elects Montserrat Castellanos Moncho as the new Chair of the ERFP.

It is agreed that Sipke Joost Hiemstra will Chair the 2021 GA meeting until its end.

<u>ERFP Steering Committee member</u> – According to the ERFP Terms of Reference, the term of office for Srdjan Stojanovic ends in 2021. **Danijela Bojkovski** from Slovenia is candidate for the election. An email was send to all NCs and no other proposal was received. The candidate briefly introduced herself to the GA.

The General Assembly elects Danijela Bojkovski as a new member of the SC.

Since Montserrat Castellanos Moncho was elected as an ERFP Chair, a new representative is needed in the Steering Committee. The proposed candidate is **Nina Sæther** from Norway. No alternate candidate are suggested. The candidate introduced herself to the GA.

The General Assembly elects Nina Sæther (Norway) as a new member of the SC.

The Secretariat takes the opportunity to thank Sipke Hiemstra for his active and friendly coordination all these years, and to thank also Srdjan Stojanovic for his time and commitment to ERFP. A virtual meeting is unfortunately not an appropriate way to thank them, and it is hoped that the GenResBridge dissemination event in Brussels will be the opportunity to do so.

The General Assembly closed its first day of meeting after the elections. It is reminded to all NCs that a webinar presenting what is ERFP and its main outcomes is held in the afternoon of that day. All the presentations are now available on the <u>ERFP website</u>.

8. Secretariat elections in 2022

The term of the current Secretariat ends in August 2022, therefore the procedure for application and selection of the new secretariat is launched according to the <u>ToR</u>.

Each National Coordinator will receive an individual email to inform him personally about the procedure. In a nutshell, any organisation interested by holding the secretariat needs to send its application by December 31th 2021, with its NC approval.

France will submit a proposal to keep the Secretariat for another term, but all proposals will be examined by the SC equally.

9. <u>Genres Bridge: presentation of the final version of the European Genetic Resources Strategy (EGRS) and validation</u>

The European Genetic Resources Strategy is presented by Sipke Hiemstra. The document was sent before the General Assembly to all NCs.

The validation process is as follow: during the General Assembly, the NCs whether they want that ERFP endorse the EGRS as a network. NCs will also be invited to indicate if their country agrees to endorse the EGRS by October 3rd. However a global follow up of the implementation of the strategy at EU and country level will be achieved in the dedicated TF (see previously).

The ERFP General Assembly expressed its support to the European Genetic Resources Strategy, prepared by the GenRes Bridge project.

10. <u>GenResBridge: presentation of the gateway, validation of the list of participants for the final event, journal sustainability</u>

All NCs and ERFP network are invited to create an account and include inputs in the <u>GenResBridge gateway</u>; the more information there is, the more interest there will be. Videos are available to explain <u>how to proceed</u> to include contents.

Official launch of the strategy: the event will be held physically in Brussels, with the possibility to attend online November 30th. Invitations will be sent directly by the GenResBridge consortium; each GenResBridge partner have travel costs covered for two persons and on top of it a total of 25 persons per network can have its travel reimbursed.

GenRes Journal sustainability: elements were provided to the ERFP network just before the General Assembly, therefore there was not time to assess them. Further work is needed to see how the ERFP network can contribute to the journal economic model.

11. GenResBridge: presentation of the European AnGR strategy – group work

Danijela Bojkovski presented briefly the European AnGR strategy which was sent to all NCs before the General Assembly. NCs and stakeholders can send their comments within two weeks.



A group work follows in order to give first insights on the action plan. All the inputs will be used by the Ad Hoc Action group to draft the first version of the action plan, which will be sent to NCs with the new draft.

The meeting ends at 12:45. Before its end the ERFP secretariat thanks all the ERFP network for its commitment with a specific word for Sipke Hiemstra for all his dedication throughout the years.

The new chair, Montserrat Castellanos thanks also the Assembly and looks forward for the achievement of all the plans ERFP have, and hopes that our common effort will help us grow.

The next GA should be held in Porto, Portugal
