Administrative and financial issues:

- Reduced fee/one day fee exemption for ERFP National Coordinator (or their representative) to attend the joint meeting(s) of ERFP/FAO/EAAP on AnGR – could be included in specifications/model agreement between EAAP and individual countries organizing committees
- Possibilities to lighten the administrative burden and to digitalize the ERFP reimbursement procedures (and more specifically to reduce/avoid the mandatory sending by slow mail of all the invoices – cf. document 3_EAAP_ERFP_ReportingV3.doc).
- Possibilities for ERFP Secretariat to pay invoices directly (rooms registration, meals, transport, etc), e.g. by credit card, without going through payment by personal funding followed by ERFP reimbursement procedure.
