

A short reminder of Task 3:

The main task was to review the support measures for individual breeds in Europe;

- Were there payments;
- If any, how were they calculated and distributed;

All information was obtained through questionnaires;

Answers obtained through questionnaires were analyzed and categorized according to the nature of the task;

The first draft of the questionnaire had 7 main sections:

- 4. DEFINITION OF THE BREEDS AND LEVEL OF ENDANGERMENT;
- 5. MEASURES OF SUPPORT PAYMENTS FOR THE Angr;
- 6. METHODS OF CALCULATION OF PAYMENTS;
- 7. PROPOSALS FOR IMPROVEMENT OF THE CURRENT SITUATION;

- 5. METHODS OF CALCULATION OF PAYMENTS;
- 6. PROPOSALS FOR IMPROVEMENT OF THE CURRENT SITUATION;
