# 1. Brief information

# 2. EC Call for Reference Centre endangered breeds / follow up of the strategies

DG SANTE launched a call for a reference Center on endangered breeds March 16th, 2022. The deadline for the application is really short (May 16th 2022). At ERFP level, the proposal was forwarded to all NCs before the SC meeting and NCs were offered to participate to this point of the agenda of the SC meeting if interested by the topic.

Discussions are made in order to present an application strongly linked with ERFP to avoid duplications and make sure about the connections between the two institutions. A consortium of three organisations, that is holding the secretariat currently (IDELE, France) and in the past (BLE, Germany) together with the organisation that chaired ERFP for two consecutive terms (CGN, The Netherlands) is favourably supported by the ERFP chair, SC and chairs. Efforts will be made to include widely the ERFP network in their work, if the consortium is elected as the EURC for endangered breeds.

Due to the strong connection between the establishment of the EURC and the TF strategy, work connected to this TF will be on hold till the result of the call is known.
