Administrative organization AnGR in France

- National coordination (FAO) SGAE/ Ministry of Agriculture and Food sovereignty (MASA) – DGPE - BLSA
- Research institute INRAE : Animal genetic resources monitoring and reporting
- Public body “Etablissement Français des produits de l’agriculture et de la mer” FranceAgriMer : **Thematic commission on AnGR, since 2020 :**
 - gathers state, research and breeding sector representatives (all species, incl. ABR-species, aviculture and aquaculture), 3 times/year.
 - Research & professional stakeholders, including animal products industries
- No official NS - AP national strategy for genetic resources endorsed yet
 - Several actions (in-vivo, in-vitro and reporting) in place
 - Value of coordination and consistency framework

Animal breeding EU regulatory framework -1/2

- **Competent Authority EU** – Animal Breeding Regulation (ABR)
 - MASA / DGPE: BCHIC equids vs BLSA ruminants and pigs
 - zoogen.dgpe@agriculture.gouv.fr
 - <https://agriculture.gouv.fr/agreements-dans-le-domaine-zootechnique>
 - Breeding programs approval, modification & extension
 - Breed societies and breeding operations recognition
- Post - ABR enforcement (2018/11) **national legal framework update :**
 - To be completed by the end of 2023
 - Includes dropping pre-ABR national breeding organization in favour of breed societies responsibility
 - Activates ABR article 28 to call data from breeding programs performed onto the national territory for administrative controls, public good research, and **animal genetic resources monitoring** > BDZN Base de Données Zootechniques Nationale (national repository for GR)

Animal breeding EU regulatory framework - 2/2

- 239 approved breeding programs (ABR article 8)
- 155 extended breeding programs (EU-countries breeding programs extended in France, ABR article 12)
- 99 recognized breed societies and 6 recognized breeding operations (hybrid pigs)
- From now, breed recognition should proceed from a breeding program approval according to ABR for regulated species

Breeding sector organization - 2/2

- Breeding operations & breeding companies
- AI cooperatives / companies, and counseling organizations
- Ruminant breeding sector organization & representation : France Génétique Elevage <http://fr.france-genetique-elevage.org/>
- Technical institutes (IFCE: horses & donkeys; IFIP : pigs, IDELE : ruminants, ITSAP : honeybees, ITAVI : avian & rabbit species with SYSAAF avian, insect & aquatic species)
- Agriculture land bodies (chambres d'agriculture) and local farming bureaux (animal identification)
- Research institutes (INRAE, IRD, CIRAD)

Endangered breed status recognition

- For endangered breeds recognition, only considering “local” breeds aka “**localized breeds**”, as :
 - where at least 30% of heads are localized within the same administrative department area (~1/100° national territory)
 - or 70% of heads are localized within three neighbouring administrative department areas (3/100° national territory) ;
- For endangered breeds recognition, in addition, only considering (FAO) :
 - **1/ native / autochthonous breeds**
 - **2/ locally adapted breeds** : > 40 years and 6 generations and significant departure from origin population (FAO, ITWG An GR 7th)
- Not considering exotic, regularly imported breeds, largely spread / mainstream breeds

N endangered breeds per species

- Only from localized + native/locally adapted breeds
- endangered breed recognition from **thresholds in number of reproductive females per breed (species reproductive capacity)** : EQ 8000 f.; BV 7500 f.; OV-CP 6000 f.; PC 1000 f.; avian species 500 f.
- **Increased thresholds where risk factors are identified** : proportion of non-breeding females, recent trend, Ne, health risk, breeders organization & breeders economic performance.
- **Revised 2023 : 168 breeds, including 93 breeds from ABR regulated species (and 75 avian species)**

In-vivo conservation : EU CAP support

- EU Endangered breeds protection (“PRM”) included in the FR CAP Plan (previous 2015-2022 & current 2023-2027 programs) as an agri-environment-climate measure (“MAEC”).
- Action 70.30 in France current NSP for CAP : Endangered breeds protection
- Conditioned to **national recognition** of Endangered Animal Breed status
- **Regional management** of priorities, breeds included among recognized EAB
- Financial management at regional level (the same breed may be supported in some but not all areas).
- “Protection races menacées” MAEC PRM funding. ~ 7 M€/y (EU & national)
- **Per head yearly support, e.g. conditioned to effective purebred effective breeding**

In-vivo : national support program


- Ruminant / Equine breed societies support with a specific focus for localized & endangered breeds : tender schemes, call for agroecological MYPOW
- Ruminant localized & endangered breeds **support to breed societies** > 1,3 M€/y
- Services of general interest for territory development and genetic resources diversity:
 - AI in remote areas (long distance shipping/AI tech move support)
 - AI in endangered breeds : 8 €/EAB AI cattle, 2.5 €/localized breed AI. : 300 000 €/y
 - Considering supporting additional breeding services in remote areas (under study)
- Technical institutes support & Research institutes support
- No (more) direct support of breeding databases, or genetic evaluation per se : breed societies responsibilities & duties.
