## **Context and comments**

• A common point between the global and AnGR strategy and the MYPOW:

The level of fulfilment will depend on the level of adoption, commitment and support from the Governments, European Institutions involved actors that should provide the financial, human and institutional resources and work required to fully execute the action plan

- Moreover: There are some other uncertainties about future activities in the long term, some of them need a ERFP orientation and GA decision
- In the specific sections of the MYPOW some KR and actions have been partially included if directly are connected to ERFP competences and are on ERFP's hand to be implemented at some point in the next years
