

Minutes of the ERFP Assembly of National Coordinators

August 29th and 30th 2024, Florence, Italy

1. Welcome and opening

a. ERFP Annual Progress report

The presented Annual Progress Report 2023-2024 was approved by the Assembly.

b. ERFP Financial report

ERFP concluded the 2023 financial year with a balance of + 410 237,53 €.

The presented final budget for 2023 was approved by the Assembly.

The general expenses in 2024 amounted to 53 790,94 € and the countries contributions to 65 800,00 €, the remaining funds are equal to 377 843,43 € - all amounts as per August 1st 2024.

Montserrat Castellanos takes the opportunity to thanks the chairs for their work. She welcomes the new chair, Ewa Sosin, ex situ WG. She was elected during the last WG held in Nicosia, Cyprus.

8. Follow up of the AHA; proposal for 2024 and 2025

Cf. slide presentation and reports for the Simmental, transhumance, Sanitary issues and Mediterranean workshop.

The General Assembly urges the AHA leaders to include a publication in the GENRES journal of their work when the topic is appropriate. Articles should be published by the Simmental and Native horses AHA. The secretariat will ask the AHA transhumance leader to draft an article based on the presentations realized during the Avila meeting.

9. Task Force Permanent Secretariat

Sipke Hiemstra as TF Chair presents the latest conclusions drafted by the team. Some NCs regret that a report was not sent before the GA to have a clearer view about the ins and outs. On the other hand, it is reminded that this topic is under process since the 2018 AHA SWOT analysis and most of the information was already presented to the NCs at previous General Assembly.

The TF will continue its work towards facilitating the option of permanent secretariat by preparing all the possible options and next steps. Meanwhile, the call for a new secretariat will be launched during the GA 2025 following the "Annex 3: Procedure for the election of



the ERFP Secretariat" of the ERFP Terms of References. The existing secretariat (IDELE) will in parallel investigate whether they are willing and able to extend their service for another term in case there is no other ERFP NC proposing another body to serve as secretariat. If IDELE can extend their service, an amendment of page 8 of the ERFP TORs will be prepared to be voted in GA 2025, to enable such extension. The TF should also work on countries' letters of commitment or an equivalent process, following what is done in the ECPGR and EUFORGEN network. The final proposal could be presented during the next General Assembly meeting and in a disconnected way from the secretariat renewal process for now.

10. Elections: Chair and Steering Committee

<u>ERFP Chair</u> - According to the ERFP Terms of Reference, the Chair of the ERFP Steering Committee is elected by the Assembly for a 3-years term and can be renewed once. Therefore, the term of office for Montserrat Castellanos Moncho will end this summer.

Danijela Bojkovski (Slovenia) is candidate for the election. An email was sent to all NCs and no other proposal was received.

The General Assembly elects Danijela Bojkovski (Slovenia) as the new Chair of the ERFP.

It is agreed Montserrat Castellanos Moncho will Chair the 2024 GA meeting until its end.

Since Mrs Danijela Bojkovski is elected, it means that there will be one seat available at the Steering Committee. Also, **Mrs Melissa Raemy (Switzerland) wishes to resign** from her current position in the Steering Committee for personal reasons.

The SC suggested two candidates:

Ante Ivanković (Croatia– East Region) Rachel Davis (UK – North Region)

The Secretariat sent their CV to all the NCs before the GA and offered to provide more candidates. No additional proposals were received.

The General Assembly elected Ante Ivanković and Rachel Davis as a new members of the SC.

The Secretariat takes the opportunity to thank Montserrat Castellanos Moncho for her active and friendly coordination all these years and wishes Melissa Raemy a successful new chapter in her life.

11. Communication activities

Cf. slide presentation and Alcandora report provided to NCs prior the General Assembly.

The SC has assessed the work carried out with Alcandora and the necessity of ERFP's presence on social media. The overall conclusion was that it is the secretariat who is actively seeking relevant information. The SC recommended that IDELE take over communication activities once the Alcandora contract expires. It seems logical for IDELE to present an



integrated proposal for both secretariat and communication tasks, similar to the approach taken by EUFORGEN and ECPGR. In response, IDELE drafted a proposal to support ERFP communication, which was sent to SC members in June. The current annual budget allocated to Alcandora is €14,000, while IDELE's proposal amounts to €8,000.

The General Assembly votes for IDELE to perform the communication activities for the next 2024/2025 period, for a total amount of 8,000 €.

The same assessment needs to be done for the GENRES journal for the next GA period (2025/2025).

Geena Cartick (EFFAB) offers her contributions for writing clear and understandable messages to our community. The chair welcomes this help and thanks Geena for it.

12. ERFP future plans and 2025 budget approval

An Ad Hoc Action will start this fall to coordinate the statements for the Europe Region at the next FAO's ITWG. Expected participants are the ITWG official members (see recap below), however all NCs are welcome to be part of the AHA. Nina Svartedal (Norway) will lead the AHA, with the help of Eleonore Charvolin-Lemaire (France).

The budget is adapted during the assembly following the decision of change of communication agency from Alcandora to IDELE.

A discussion follows on the AHA budget. It is reminded that AHA should follow the ERFP key recommendations and action plan. The assembly agrees for a 41 000 € budget for the AHA.

The 2025 budget was <u>approved</u>, with Italy's abstention.

The budget includes a partial funding of the GENRES journal; the secretariat will contact the ECPG secretariat to let them know about our budget involvement for 2025. The first agreement with ECPGR was that ERFP would help with the journal sustainability at least for a two-year period. With the voting of the 2025 budget, the ERFP network commits itself for a third year.
